- 7. The school shall not collect any capitation fee and subject the child or his or her parentor guardian to any screening procedure.
- 8. The school shall not deny admission to any child,

 - e. The teachers are recruited with minimum qualifications as laid under G.O.Ms. No.01 Edn, dated 1-1-1994 Of A.P.State.
 - f. The teachers perform his duties specified under G.O.Ms. No.01 Edn, dated 1-1-1994 Of A.P.State.
- 10. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
- 11. The school shall maintain the standards and norms as specified in AP EDUCATION ACT,182
- 12. No unrecognized classes shall run within the premises of the school or outside in the name of school.
- 13. The school building plan must have been approved by the current rules or G.Os. The school building or other structures and the grounds are used only for the purposes of education and skill development. Construction work within the compound should not be carried out in school working hours and safety measures in all respect are under whole responsibility managements.
